# **LOCAL**

#### **Clovis Committee Meeting in July**

**Update on VMT mitigation measures** – Renee Mathis reported that they had made progress, although slowly, but continued to gather information. Renee stated that they had contacted cities that have implemented a fee program and would continue to review the data.

**Permit trends** – Jesse Norton reported that the city had issued 662 single family permits and zero permits for multi-family units. Jesse stated that they were projecting about 750 units for fiscal year 2023-24 with about 590 multi-family units that were in process in 2022-23 being issued in 2023-24 with the rest in single family residential.

**Update on the Housing Element** – Dave Merchen informed the Committee that the Housing Element had been submitted to HCD and was expecting a response by mid-August. Dave stated that they had one meeting with HCD. Dave indicated that the goal was to get the Housing Element approved by HCD by December.

Analysis of Inclusionary Zoning – Dave Merchen reported that the city had been included in a study on inclusionary zoning and based on the information provided by the development community and the city to the consultant, Clovis was removed from the study,

Changes to R-3 and R-4 zone districts – Dave Merchen informed the Committee that the city needed to make changes to the R-3 and R-4 zone districts to comply with the new Housing Element. Dave stated that he would be conducting a meeting in early August to review the proposed changes and asked for participation from the BIA.

General Plan Review and Audit – Dave Merchen stated that the review and audit of the current General Plan was being reviewed by staff and would be released soon. Dave stated that they had scheduled a hearing before the City Council on August 21 to consider the report findings and recommendations.

Processing improvements – Sean Smith reviewed the statistics on improving processing times and the planned future improvements. Sean requested that anyone with comments on processing times should contact him.
